The Georgia Horse Council, in conjunction with Southern States will present the third Triple Crown Super Barrel Race Show January 9-11, 2009 at the Georgia National Fairgrounds in Perry, Georgia. Southern States Triple Crown Super Show has a history of great participation with this event and the Georgia Horse Council is expecting a great turn out.

All vendors will be placed in the Reaves Arena as we will not have seminars or other activities on the grounds. The application for vendor participation is being sent out early in order to give all vendors the opportunity to accommodate the barrel horse industry. You may start setting up Thursday, January 8 at noon. You will not be charged for your set-up day unless you start selling. Your charges will start on Friday, January 9, so you will be charged the \$100.00 per day for 3 days (\$300.00). **Please notice that the fees have changed.**

Insurance is required for ALL vendors who sell merchandise on the premises. The required liability policy should be in the amount of One (1) million dollars and the following statement listed on the insurance cover. ***“Georgia Agricultural Exposition Authority, its board members, officers, agents and employees of the Authority, and the State of Georgia, are listed as additional insured’s, but only with respect to claims that are not covered by the Georgia Torts Claims Act, O.C.G.A. 50-21-29, et seq.”*** If you need coverage, we can provide insurance for the charge of \$88.00 for the weekend event. Please indicate on your contract if we need to provide insurance.
